

- Any correspondence (or information about discussions held) between the Mayor and CE of Tasman District Council to the Mayor or CE of Whanganui District Council confirming whether Tasman District Council were in favour or opposed to the Mid West Ferry Proposal.

Unfortunately, we do not hold the information you have requested. Staff in the Mayor's Office and the Chief Executive's Office have undertaken a full and historic search of emails. Our IT department have also undertaken the necessary email searches. I am therefore refusing your request under section 17(g) of the LGOIMA because the information is not held.

Although this information falls slightly outside of the scope of your request we have **attached** emails from Tasman District Council, Chief Executive Officer, Lindsay McKenzie to Whanganui District Council, Manager Special Projects, Rowan McGregor as these emails indicate an opposition to the proposal.

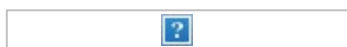

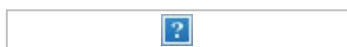
